Nistar Distribution in Vidarbha Region.

R E S O L U T I O N

Prior to the abolition of the District Development Boards the work of distribution of Nistar in Vidarbha Region was regulated and controlled by a Subject Committee of the District Development Board concerned and actual permits were issued by a Sub-Committee or taluka Committee. Consequent on the establishment of the Zilla Parishads, the District Development Boards have been abolished. Government is, therefore, pleased to direct that the work of distribution of Nistar in Vidarbha Region should now be entrusted to the Zilla Parishads/ Panchayat Samitis concerned. The following functions should be entrusted to the Panchayat Samitis concerned:-

- i) Assessing the demand of poles and fuel from the respective villages;
- ii) Recommending names of the coupe's for Nistar, considering their value, the condition of crop and the accessibility to the villagers. For this purpose the meeting of the Panchayat Samitis should be held in the month of May, every year;
- iii) Selection of villagers to receive Nistar.
- iv) Fixing quantum of Nistar for cultivators and regulating its distribution amongst the cultivators.
- v) Publicity regarding Nistar arrangement; and
- vi) Hearing and disposal of complaints regarding Nistar.

2. The Divisional Forest Officer/ Sub-Divisional Forests Officer will act as a technical adviser to the Zilla Parishad and the ranger to the Panchayat Samiti respectively. The technical advice of these officers will be binding on the Zilla Parishad, or Panchayat Samities as the case may be and in the event of difference of opinion, the Chief Conservator of Forests will decide the matter.
